Introduction

In my capacity as the Commissioner of the Independent Legal Services Commission ("the Commission"), I am pleased to present to you and the Honourable Acting Chief Justice Salesi Temo the Consolidated Interim Report for the period 2019 to 2022 by virtue of section 96 of the Legal Practitioners Act 2009.

I was appointed on 28 February 2022 for a term of three years. However, as I have tendered my resignation with effect from 30th June 2023, I am submitting this Consolidated Interim Report for your information as it has not been practically possible to compile the annual report due to the non-availability of the audited accounts.

Similarly, due to the non-availability of audited accounts, the previous Commissioners were also not in a position to submit their annual reports as required by Section 96 of the Legal Practitioners Act. However, Dr. Thomas Hickie did prepare and compile the Annual Reports for 2017 and 2018 and submitted the same as required by section 96 of the Legal Practitioners Act. These two reports have been returned due to the audited annual accounts not being attached to the said Annual Report of 2018.

Financial Statements .

As the Commission did not have the audited accounts or the financial statements for the years 2016 to 2022, upon calling for quotations, the accounting firm, BDO was engaged to compile and prepare the financial statements for the years 2017-2022. This process commenced on 17

October 2022 and BDO has compiled and finalised the financial statements up to the year ended 31st December 2022 of which the Auditor General has audited the accounts for the years 2016 to 2018. The accounts for the years 2019 to 2021 have been submitted to the Auditor General for auditing purposes and the same is pending. The financial statements for the year ended 31st December 2022 prepared by BDO is in draft form, however, the same will be submitted for auditing in due course.
